

### NOTICE TO BIDDERS

Sealed bids will be received by the Johnson County Clerk until May 7, 2024 at 9:45 a.m. and opened shortly thereafter, for the construction of approximately 0.7 miles grading, rock surface course, and other related incidental work in Johnson County. The project site is located as follows: 722 Road Grading - on 614<sup>th</sup> Avenue and 722<sup>nd</sup> Road between 614<sup>th</sup> Avenue and 615<sup>th</sup> Avenue, in Johnson County, Nebraska.

The project is referred to as "Johnson County - 722 Road Grading" and shall include all labor, materials, transportation and equipment required for the construction of approximately 0.7 miles of grading and rock surfacing and other related incidental work.

Copies of the Bid Documents and Specifications are open to public inspection at the office of the Johnson County Clerk, Johnson County Courthouse, 351 Broadway, Tecumseh, Nebraska 68450. A set of documents may be obtained from Mainelli Wagner & Associates, Inc. for a non-refundable fee of \$30.00. (6920 Van Dorn Street, Lincoln, Nebraska 68506 PH: 402-421-1717). All Bid Proposals must be submitted on the forms furnished with the Bid Documents.

The sealed bids may be mailed or delivered to the County Clerk of Johnson County, 351 Broadway St., Tecumseh, Nebraska 68450, and should be plainly marked as, "Construction Bid Proposal – 722 Road Grading".

Along with its Bid Proposal, each bidder shall submit an unconditional Bid Bond or Certified Check made payable to the County Treasurer of Johnson County, Nebraska, in an amount equal to five (5) percent of the Bid Proposal. Also, each bidder is to provide a Start of Construction date and End of Construction date for project with its Bid Proposal. The desired completion date is September 1, 2024. The Contractor will be allowed thirty (30) calendar days. The required completion date will be the earlier of the dates indicated in the bid proposal or the actual start date plus the allotted calendar days. Additional days due to weather may be granted at the discretion of the Engineer.

Within ten (10) days following the award of the Contract, the successful bidder shall furnish a surety bond or bonds in an amount equal to or greater than the full amount of the contract. The surety and form of the bonds are subject to the acceptance by the Johnson County Board of Supervisors.

The Johnson County Board of Supervisors reserves the right to reject any and all bids or to waive any irregularities in bids received. Award of the Contract will be in accordance with the County Purchasing Act's competitive bidding considerations as set forth in Neb.Rev.Stat. §§ 23-3110 to 23-3114. Johnson County is an Equal Opportunity Employer.
