NOTICE TO BIDDERS

Sealed bids will be received at the office of the Saunders County Clerk until March 26, 2019 at 9:00 a.m. and opened shortly thereafter for the construction of two overlay projects and two patching projects. The project sites are located as follows: (709)- on County Road K beginning at South Pine Street and continuing east approximately 3.0 miles to County Road 13; (741)- on County Road J approximately 1,000 feet east of Highway 77 and continuing east 800 feet to the Wahoo city limits; Road R Patching- approximately 6.8 miles on Co. Road R beginning at the intersection of State Spur S12B and Co. Road 39 in Butler County and continuing east along Co. Road R, ending at Hwy 79; and Road X Patching- approximately 8.5 miles on Co. Road X from Hwy 79 to North 2nd in Cedar Bluffs Street including the approximately 800 feet of Co. Road 25 north of Co. Road X, all in Saunders County, Nebraska.

The project is referred to as "2019 Saunders County Asphalt, C-78(709), C-78(741), Road R, and Road X" and shall include all labor, materials, transportation and equipment required for the construction of: patching, cold milling, subgrade preparation, earthwork, asphaltic concrete, type "SPR" (full depth and overlay), earth shoulder construction, seeding, erosion control, and related incidental work.

Copies of the Bid Documents and Specifications are open to public inspection at the Saunders County Highway Superintendent's Office, 426 N Broadway St., Wahoo, Nebraska 68066. A set of documents may be obtained from Mainelli Wagner & Associates, Inc. 6920 Van Dorn Street, Suite "A", Lincoln, NE 68506 (Phone: 402-421-1717) for a non-refundable fee of \$50.00. All Bid Proposals must be submitted on the forms furnished with the Bid Documents.

The sealed bids may be mailed or delivered to the County Clerk of Saunders County, Saunders County Courthouse, 433 N Chestnut St., P.O. Box 61 Wahoo, Nebraska 68066, and should be plainly marked as, "Construction Bid Proposal – 2019 Saunders County Asphalt, C-78(709), C-78(741), Road R, and Road X".

Along with its Bid Proposal, each bidder shall submit an unconditional Bid Bond or Certified Check payable to the County Treasurer of Saunders County, Nebraska, in an amount equal to five (5) percent of the Bid Proposal. Also, each bidder is to provide a Start of Construction date and End of Construction date for each site with their Bid Proposal. The required completion date for (709) and (741) is October 31, 2019 and the desired completion date for Road R and Road X is June 15, 2019. The successful bidder (i.e. Contractor) will be allowed eighty-five (85) calendar days for C-78(709), fourteen (14) calendar days for C-78(741), and twenty-one (21) calendar days for Road R and Road X for completion after beginning work. The Completion Date shall be the earlier of the date indicated in the Bid Proposal, or the actual start date plus the allotted calendar days. Additional days due to weather may be granted at the discretion of the Engineer.

Within ten (10) days following the award of the Contract, the successful bidder shall furnish a surety bond or bonds in an amount equal to or greater than the full amount of the contract. The surety and form of the bonds are subject to acceptance by the Saunders County Board of Supervisors.

Saunders County, in accordance with Title VI of the Civil Rights Act of 1964, 78 Stat. 252, 42 U.S.C. 2000d to 2000d-4 and Title 49, Code of Federal Regulations, Dept. of Transportation, Subtitle A, Office of Secretary, Part 21, Nondiscrimination in Federally assisted programs of the Dept. of Transportation issued pursuant to such Act, hereby notifies all bidders that it will affirmatively insure that in any contract entered into pursuant to this advertisement, minority business enterprises will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, or national origin, sex, age and disability/handicap in consideration for award.

The Saunders County Board of Supervisors reserves the right to reject any and all bids or to waive any irregularities in bids received. Award of the Contract will be in accordance with the County Purchasing Act's competitive bidding considerations as set forth in Neb.Rev.Stat. §§ 23-3110 to 23-3114.
